Minute of regular meeting held at Burghead Harbour Office on Thursday 4th February 2016

The Chair opened the meeting at 7.30

Police Report

This report covers the period 29 November 2015 to 3 February 2016. During this time, only five crimes and offences have been recorded in the Burghead and Cummingston areas. These include Theft, Road Traffic Offences, Possession of drugs and an offensive weapon and sending sexually offensive images by social media.

Sometime between 0130 hours and 1330 hours on Sunday (Saturday night) 6 December 2015, the Harbour Bar, Granary Street, Burghead, was entered through an insecure door and a large three figure sum of cash was stolen.

A 32 year old local female has been reported to the Procurator Fiscal for driving in Burghead during the late evening of 18 January 2016 whilst being only the holder of a Provisional Drivers Licence without being accompanied by a suitably qualified driver.

Several motorists have been charged and issued fixed penalty notices for speeding offences as a result of checks carried out in the area by local officers.

Nightshift patrols in the Lossiemouth and Burghead areas continue and residents are encouraged to immediately report any suspicious persons or vehicles, particularly in rural locations.

FEEDBACK ON POLICE ACTIONS IN RESPONSE TO MATTERS RAISED AT THE PREVIOUS MEETING

Local Policing Team officers, in conjunction with Moray Council Community Wardens, have been operating speed checks in the vicinity of Burghead Primary School, along with P6/7 pupils to raise awareness of the issue of speeding motorists in the area.

There was discussion about the severity of the drug problem in Burghead. Reassurance was given that there was no evidence of a serious problem or crime relating to it.

Community Warden Report

Community Issues in Burghead and Cummingston 1st December 2015 – 4th February 2016 Anti social behaviour:

- Anti social behaviour and its causes are continuing to be targeted along with Police Scotland and other partners.
- On Friday 11th December an Operation Avon was undertaken with Police Scotland, Moray Youth
 Justice and Community Wardens engaging with young people in the Lossiemouth, Hopeman
 and Burghead areas in a bid to deter underage drinking and antisocial behaviour.

Abandoned vehicles:

- The vehicle opposite the Scot-Mid on Grant St has now been uplifted.
- One vehicle was reported at Station Park; after enquiries the vehicle has now been moved the registered keeper.

Dog fouling:

- Two complaints regarding dog fouling were received in this period; as a result one resident has been spoken to and enquiries have been made in the Siguard Street and Siguard Way area with residents spoken to and given advice.
- We continue to urge people who witness dog fouling to report it on 07800 670 665; information provided by members of the public is invaluable when it comes to identifying and dealing with dog foulers.

Tim Betts explained about the difficulties of dealing with dog fouling with reference to disabled people. It is impractical to issue penalty notices, but he can advise individuals if it is brought to his attention.

Initiatives:

Speed checks:

After concerns were raised about vehicles speeding along Grant Street, the P6/7 pupils have been operating speed checks on Grant St in conjunction with PCs Fraser and McGettrick from Police Scotland. There are plans for further checks in the next fortnight.
