GETTING IT RIGHT FOR EVERY CHILD

Children and Young People's (Scotland) Act 2014, draft guidance (GIRFEC) -. Based on comments that the Scottish Government received on this they are in the process of developing revised draft guidance with a view for this to go out for further consultation in November and the final guidance ready for the spring. Meanwhile the Scottish Government have produced a response to the first consultation that can be found [here](#). This also details the work happening to develop practice guidance and resources for the implementing of GIRFEC aspects of the Act.

Locally, work is ongoing to refresh, revise and develop existing and new processes and paperwork to ensure that they meet the legal requirements for August 2016.

Existing paperwork such as the Child's Plan should still be used pending the final guidance.
