b.	<p><u>WELCOME</u></p> <p>Alastair Kennedy welcomed everyone to the meeting.</p>	
c.	<p><u>SPEAKER (Ken Kennedy)</u></p> <p>Ken Kennedy outlined the huge scope of work that his grounds maintenance department undertakes on a budget of just £1.2m offset by income from burials etc. He explained the pressures on his department and some of the strategies they use to make best use of the resources and approx. 70 employees. The growing of bedding plants is now undertaken by the Green Fingers social enterprise and Moray Council buys plants from them. The areas planted by his team are only at war memorials.</p> <p>Cemeteries were discussed. Elgin Cemetery has a life span of 9 years and it is not possible to buy a lair without having an interment. Aileen Marshall asked what obligations lair holders or the families of the occupants had for maintenance. Families have no obligations other than the safety of the headstone.</p> <p>There was a discussion on who is responsible for overhanging trees etc on the River Lossie and the potential impact on flooding. There was some doubt about this and it was agreed that Alastair Kennedy will ask for clarification from Steve Cooper on who is responsible for flood risk assessment and actioning the removal of trolleys, overhanging branches, etc from the River Lossie, Tyock Burn etc.</p> <p>The problem of giant hogweed was raised. It is the land owner's responsibility to treat giant hogweed but Moray Council tend to do it around core paths and public areas. There is also a strategy being developed by the Lossie, Nairn and Findhorn fisheries board to eradicate giant hogweed in their areas.</p> <p>Cllr Patsy Gowans helped highlight the extent of budget and staff reductions that had been accommodated by improvements in equipment, capability and efficiency within the department.</p>

	<p>Meeting with Network Rail is rescheduled for 16 August 2016 due to strike action.</p> <p>St Giles Centre toilets charging scheme is in progress however, Alastair Kennedy made comment that standard of cleanliness was not great. There were no objections to that statement. He had written to the owners via the St Giles Centre management team and is awaiting a response.</p> <p>Community Engagement by Moray Community Planning Partnership requires special meeting.</p> <p>The fountain in Elgin town centre is working again.</p> <p>Maureen Manson has resigned from ECC due to other commitments although she will remain on the Grant Lodge committee. Alastair Kennedy thanked her in her absence for all the work she had done for ECC.</p>	All
4.	<u>AGENCY UPDATES</u>	
a.	<p><u>POLICE SCOTLAND</u></p> <p>See report.</p> <p>In relation to the drugs crime in Northport which also involved bypassing the electricity meter, Sgt Sean Jones highlighted the beneficial impact that dealing with the crime would have on the neighbourhood including safety of neighbours and integrity of their electricity supply.</p> <p>In response to a question it was confirmed that failing the road side eyesight test was an offence.</p>	
b.	<p><u>STAGECOACH</u></p> <p>Craig Woodall apologised for the recent absence of Stagecoach from ECC meetings.</p> <p>Services to Inverness have changed due to a downturn in passenger numbers although the half hourly service is maintained. The rail strike had an impact on increasing passenger numbers.</p> <p>The Buckie service was retained after a petition was received and Stagecoach are pleased to be able to retain this service.</p> <p>Delays on A96 are expected due to work in the vicinity of the bus depot.</p> <p>Real time information was discussed. The data is available from the buses but there are some issues around how it is published to passengers. Mobile apps seem to be the most reliable. It does not seem to be a financial priority for Moray Council to upgrade the real time signs at bus shelters and the bus station to make use of the real time information available now from Stagecoach.</p> <p>Cllr Patsy Gowans had received complaints that the 11 service had been reduced but was still advertised on the timetable.</p> <p>Iain Catto asked about heating control on buses which on occasions he found uncomfortable. Craig Woodall advised that changing the heating settings was an engineering task not a driver task hence the problem.</p> <p>David Chapman, Eddie Wallace and Gordon Methven raised a number of problems at the bus station as follows:</p> <p>Buses coming in to the wrong bay or with the wrong livery leading to people missing their bus. Craig Woodall undertook to remind his drivers of their duty to advise customers when they are in the wrong bay. He also said that whilst they try to ensure the correct livery, if a bus develops a fault they sometimes have to use whichever bus they can get rather than failing customers.</p> <p>The banksman is no longer present. Manoeuvring of buses is less safe without this presence.</p> <p>Buses sometimes stop too far from the kerb in the bus stance making it difficult for elderly people to get on the bus.</p> <p>Buses queue on to A96 on occasions causing delays.</p> <p>Alastair Kennedy thanked Craig Woodall for attending and hoped the feedback was beneficial.</p>	<p>CW</p> <p>CW</p> <p>CW</p> <p>CW</p> <p>CW</p> <p>CW</p>

However, Ken Kennedy pointed out that bread is not best for the ducks and grain should be fed. Also would help the pond if it was placed on the ground, not the pond. Food spread on the pond causes algae blooms on occasions in spite of efforts to reduce it. Some of the current measures were discussed.</p> <p>A change in the law allows dog fouling to be reported by only one witness provided sufficient details are provided. It is not always necessary to know the name of the person. Sometimes, the circumstances are sufficient.</p>

Drugs

On 1 July 2016 as drug search warrant was executed at an address in Northport, Elgin and a growing productive Cannabis cultivation was found within. The electricity had been bypassed. Obviously such behaviour presents significant safety issues not only for the occupier of the property by neighbouring properties too. A 25 year old man has been reported to the Procurator Fiscal.

Acquisitive Crime

Overnight on 15/16 June 2016 Harry Gows Bakery at Moycroft Road, Elgin was broken into and some money was stolen.

During the month two shed were broken into in the High Street and Braemorrison Road areas where mountain bikes were stolen. The first was a red and white Scott Voltage bike and the other a grey, blue and white Saracen Vengeance.

Violence/Domestic Abuse

There were 21 assaults reported last month and offenders were traced and charged with 13 of these crimes. 8 are still the subject of enquiry.

There were two serious assaults:

Firstly, a 24 year old woman was charged with seriously assaulting a 30 year old woman at an address in Forbes Court, and secondly, a 33 year old man was charged with assaulting another customer at a Bar in High Street, Elgin.

There were 11 reports of domestic abuse. 8 offenders were traced and reported to the Procurator Fiscal and 3 investigations are still ongoing.

Roads Policing

On 22 June 2016, a 32 year old man was charged with drink driving in Moss Street, Elgin.

On 10 July 2016, a 36 year old man left the scene of a road accident on the A96 outside Elgin and when stopped was found to be unfit to drive through intoxication by drink or drugs.

On 23 June 2016 a 77 year old male was charged with Careless Driving following a collision on Maisondieu Road, Elgin. He also failed an eyesight test and will be reported for that.

Anti-Social Behaviour

On 6 July 2016, 5 youths created a disturbance at PINZ Bowling, Elgin. They have all been charged and will enter the youth justice process.
