2. Minutes

The minutes from the last meeting were proposed by Bert Reid and seconded by Gladys MacKenzie.

3. Matters Arising

The new flags have arrived and Bert Reid will take charge of putting them up and they will be removed again sometime during the month of October.

Cathleen Harper advised that the tenants of 13 Craigview Road, Portknockie were now staying in the property.

4. Police Matters

No Police in attendance and no report emailed through.

5. Matters for Elected Members

Cllr. Shepherd advised that a new person has been appointed to check the garage sites, etc and he may well have been down already.

Gladys MacKenzie advised that the Square in front of the Victoria Hotel road is an awful mess of potholes, etc and a lot of elderly people walk that way to the Chemist. Gladys MacKenzie advised that the Council had been out and did the necessary repairs on Bridge Street but they didn't go down as far as the Square. Cllr.
