The Chair opened the meeting at 7.30

The police were not present at the meeting.

#### **Adoption of minute of previous meeting:**

Rosie Craig was welcomed as the new BCCC member for Cummingston.

Albert Main will be the new BCCC member from Burghead.

Action: Billy to arrange co-option for Rosie Craig and Albert Main.

There is to be no new secretary. Les will check all incoming emails and distribute correspondence. Joan and Kelly will take minutes.

#### **Discussion with Community Warden Tim Betts**

Burghead has not been a busy area for the Community Warden.

The biggest issue is dog fouling, and all agreed it was an important – and growing – problem.

Most prosecutions for dog fouling come from information from members of the public.

The use of cameras was discussed in sensitive areas such as the Community Garden. Cameras cannot be used (without safeguards) in someone else's property, or public spaces.

Cameras have been used in Hopeman, so we will contact Terry Brown.

Tim will give Joan signs to use in the Community Garden. Action: Tim.

This will be investigated by someone from the Council. (Antisocial Behaviour unit)

School closures

Council Budget Consultation exercise was discussed.  
Details have been on the Facebook site. Joan suggested we should respond as BCCC, but there was no interest.

Drain tops missing in Dunbar Street.  
These have been sorted out.

Bus stop placement.  
The bus stop is being moved.

### **New business**

It was agreed the Facebook page should only have what has previously been discussed in BCCC. Joan appealed for more committee members to post on the Facebook page. (This is followed by 230 people)

Planning permission for new building at 60 Granary Street. BCCC will object to this on grounds of height. Action: Les.
