Extra lights are planned for the future for the lights to be seen from all quarters including areas at the seafront.</p> <ul style="list-style-type: none"> • Contact with Mr Stewart, Brae Moray, Prospect Terrace has proved difficult via email due to his ill health. Negotiations are ongoing, as he wishes to repair the house, however a demolition order will be issued by the council if negotiations cease. • A budget of £60,000 will be allocated in the next budget to reinstate CCTV in the town. • The new Lossiemouth High School has been estimated at £41 million. This figure is being looked at to see if they can reduce this amount to £36 million. The Scottish Government has allocated £17.8 million for this project and Moray Council has allocated £13.7 million. At present there is a shortfall.
