### **Chronologies Update**

When a significant event happens in a child or young person's life it is vital that it is noted accurately in a single agency, or if appropriate multi-agency, chronology.

If a Named Person is submitting a Child's Plan and requesting support for a child from social work, then a chronology should be included as part of that request.
