Matters Arising.

Dredger

The dredger is now crewed, back in operation and expected to be in Burghead week commencing 6 May 19. It is also hoped that Harbour Users will speak with the Dredger Captain so that work can be carried out at the most beneficial points.

Change of Bank Account Signatories

Confirmation is still awaited, from Bank of Scotland, that the changes to the Bank Mandate have been made. Note: Revised documents were re-submitted on 21 Apr 19. The Minutes Secretary is still receiving Statements, the latest being on 16 May 19.

Disabled Parking Bays on Granary Street, Burghead

Action is still awaited on the removal of a disabled bay on Granary Street. Cllr. Edwards offered to chase up the matter.

Dead Seal at Millie Burn

The carcase has been removed.

Other Council Issues

Jim Patterson had attended several further meetings with the Moray Council;

i) School Crossing Patrols; although not directly involving Burghead and Cummingston, the meeting received a positive response from parents in

Lossiemouth and further afield that donations could be made to retain School Crossing Patrols. Moray Council did not disregard the offer and further information is awaited.

- ii) Grass Cutting; Talks are on-going with the Council regarding this matter across the wider area. However, the Community Council wished to express its thanks to George Watt for the work that he had put in at Burghead. This was most appreciated.
- iii) Public Toilets; There is a possibility that the toilets in Burghead could be retained "for Harbour use". There are potentially 6 volunteers in Cummingston that are investigating a lease arrangement and considering setting up collection boxes for both money and materials. There is also a possibility that Moray Speyside Tourism may take on all the toilets but this would be dependent on its ability to set up a "Tourism Improvement District" as its funding from Moray Council is now coming to an end.
