4) Matters arising from previous meeting.

- Corrections:-
 - There was a small discussion regards the Seatown bins on pavements. Possible solution would be the potential of Seafield Estate selling sections of pavements to householders for bin storage.
 - The ATM discussions were still in progress, though the discussions were all positive and a good outcome is envisaged. The issue of finding a site is proving troublesome however due to insurance costs and Link ruling out a stand alone facility due to security concerns.
 - Councillor Donald Gatt provided an update on the Logie Park playpark in that it is doubtful that funding would be available for any upgrade required due to lack of funds at Moray Council and a bid for outside funding being unsuccessful.
- Matters arising:-
 - 20mph speed limit @ Seatown. Police Scotland have said they will do speed checks in the Seatown area and A98 approaches in general following the passing on of 'speeding cars complaint ' They will report back to the January meeting. A traffic count speed survey will be carried out in the Seatown area during the Summer months:- date to be confirmed and another on the A98 around the Community Centre to gather up to date info for where majority of school children cross. The current data held by MC for the Seatown is from a survey done in 2005

and can be regarded as out of date. Once the result of this new survey is known an informative decision can be made on the 20mph limit. An E-mail from Kevin Price, MC, states the 2005 survey showed average speeds below 20mph.
