9. When do the existing contracts for the switching network and wireless network expire?

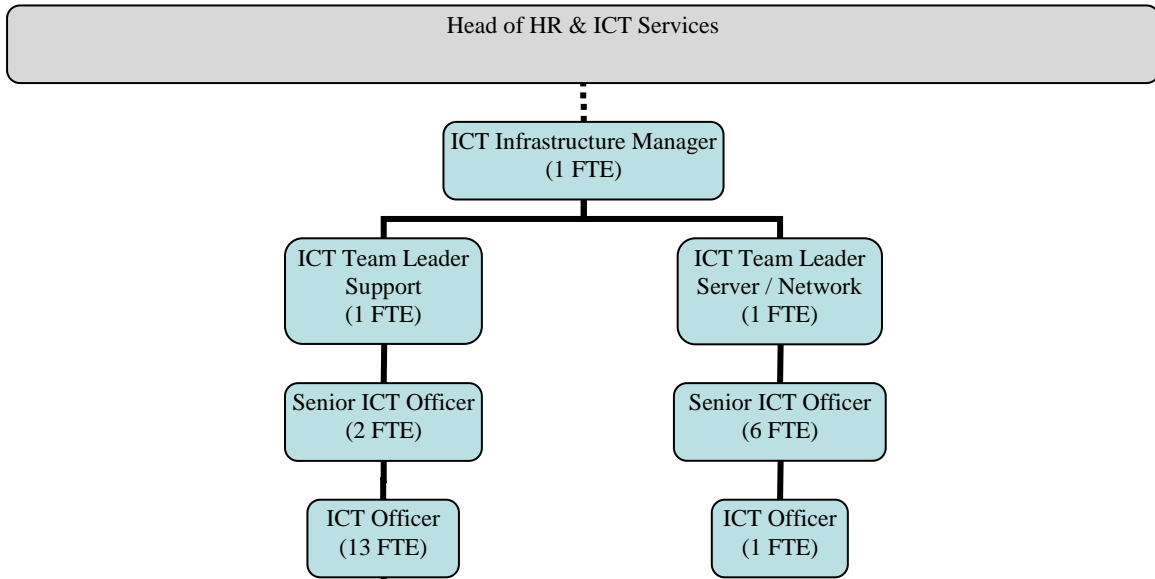
