Resilience Diversification Innovation





Our focus during Q4, as an integral part of the Economic Growth & Regeneration Team continued to be on business support through administering the Strategic Framework Business Fund as well as the Top up fund for hospitaity and retail, the Small Accommodation Providers Paying Council Tax Fund (Waves 1,2 and 3). We also assisted the NDR/ Taxation Team to deliver the Exclusive Use Grant and the Large Self-Catering Grant in conjunction with the SFB Fund. The Economic Gorwth and regeneration Team were also tasked with developing new support packages using the additional dicsretionary funds made available to local authorites to help businesses to re-start after the lockdown which started on 26 Dec 2020. This resulted in the Discretionary Business Re-start Grants. This fund provides a one-off re-start grant of £8,000 to successful applicants which pay NDR & have not been able to access any funding since October 2020. Launch will be 9 April 21.

BUSINESS START UPS

Due to the Covid-19 outbreak we expected start-up activity to decrease and in Q 4 and unfortunately this has happened – we have seen the lowest number of start-ups since Business Gateway launched in 2009 in Q4 with a total of 2 new ventures recorded as starting up and registering with HMRC – this brings the total start-ups for the year to 91. Although the target set in March 2020 before the pandemic impacted our local economy, have not been met – we are encouraged with the overall number of new ventures that have started up with BG Moray interventions during these challenging times. Many proposed start-ups may have delayed setting up their new ventures until the current restrictions start to ease from April through June 21 and our intention is to engage again with the entrepreneurs who have indicated that this was their intention to assure them that BG Moray is there to support them in any way we can. In addition, people will be facing redundancy as the furlough scheme comes to an end in September 2021 and individuals will have to look at their options to ensure they have an income in uncertain times both economically and personally. Considering self-employment will be one option and we are ready to meet that challenge and support people who want to consider this as a way forward in 2021.

ADDITIONAL LOCAL ACTIVITIES

During Q4, much of our efforts in supporting businesses have continued to be taken up responding to the COVID-19 pandemic and its impact on the Moray economy. BG has played an integral role along with EDR colleagues in Moray Council in setting up the processes and delivering grant funding to businesses through various government schemes.

However in February BG Moray was invited to guest on a Brexit Webinar hosted by Moray Chamber of Commerce to highlight the support that is being offered to Moray businesses through the newly procured Brexit specialist support Programme which will run for 2 years from Jan 2021 as part of the Moray Economic Recovery Plan

FORWARD PLANNING

Local plans: As we move into Q1 2021/22 we will continue to manage and deliver all BG products and services. These plans are now in place ready for the year ahead. We will continue to deliver 1-2-1 start up and business growth advice in-house using online platforms in the short term. We will also be offering specialist sectoral support, Digital Boost Programme and start up and growth webinars online via Teams and Zoom. Face to face support is not likely to take place with businesses for some time given the planned rollout of the vaccine programme. However, we have built in flexibility to deliver face to face when it becomes safe for us to do so – either in the BG premises in Elgin or at the businesses premises we are supporting. (Risk assessments having been undertaken)

BG National Marketing Unit will launch a new campaign focussed on support awareness in Q1 2021/22

Moray Economic Recovery Plan: Business Gateway will continue to lead on the delivery of BREXIT and Procurement 1-2-1 support for businesses in conjunction with HIE. Funding was agreed by Council along with the delivery of this type of support as part of the overall recovery plan.

Covid-19 related funds: We will continue with our EDR colleagues, to deliver funds via the Strategic Framework Fund until final payments for this fund are made on or around 19 April along with a new proposed fund - Moray Council Discretionary Re-Start Fund (utilising additional funds made available to all LA's). This fund will provide a one-off re-start grant of £8,000 to successful applicants which pay NDR & have not been able to access any funding since October 2020 with the exception of any small Discretionary Business Fund grants. Funds will be issued on a first come first served basis & will close once the allocated budget is spent.
