## **Police Report**

No representatives of Police Scotland were present: The Community Safety Partnership Report issue 55 had been received showing no incidents within the Burghead/Cummingston vicinity.

## **Guest Presentation**

Guest speakers Fiona McPherson Involvement officer and Iain Macdonald Locality Manager from Health and Social Care department Moray explained the reasoning behind the current closure of the Doctors surgeries in Burghead and Hopeman. A survey of both facilities will be carried out to assess the practicality of reopening. In the meantime, a period of consultation within the communities will commence. In Burghead this will be in a way of drop-in events within the village coupled with a questionnaire, this will commence soon and should to be completed by the end of January at which time the finding will be presented at the Moray Integration Joint Board (IJB) meeting.

Several questions were asked during the presentation, all were focused on the ways forward to resolve the problem. Danielle Slater and Jim Patterson volunteered to be part of the community working group to liaise and setup the drop-in event. Liz Mcknockiter has also requested to be involved.

## Matters Arising.

#### **Positions on the Community Council:**

Following the previous inaugural meeting the positions of Deputy Chairperson and Secretary needed to be filled. The current Chairperson Jim Patterson proposed Billy Davidson as the Deputy Chairperson this was seconded by Jennifer Walker.

The position of Secretary is still open. Jim Patterson said he would type up the minutes if someone was scribe during the meetings.

Clavie event: insurance:

A question was raised at the previous meeting about insuring the Clavie event. Would the community council insurance cover this event? An additional premium may be payable. The insurance policies have previously covered fireworks events. The community council would have to contact Zurich to discuss additional premiums.

**Action:** Billy Davidson to follow up the possibility of the Clavie organisation being a sub group of the Burghead and Cummingston community council.

#### **Burghead Outdoor Bowling Club:**

The club own the building but do not own the land. Insurance for the premises has been paid for by Moray Council and the club have reimbursed them for this.

Could this site be considered as a Community Asset Transfer?

**Action:** Moray Councillor Cowe to check details regarding the land ownership. Details for what constitutes a Community Asset Transfer have already been forwarded to the Bowling club via Abbey Main.

#### Pipes protruding at back shore-

Photos had been taken of these pipes that protrude. They are noticeable at low tide but pose a risk to water sports users.

**Action:** Liz McKnockiter Photos have been passed to the appropriate office via the Burghead Maltings awaiting outcome.

#### Poverty in Moray presentation-

Liz McKnockiter had attended a presentation by Fi Thomson. This discussed actions and that energy prices needed to be considered.

**Action:** Liz McKnockiter discuss what actions need to be done to mitigate the effect on those residents impacted.
