## 1. Welcome

Colin Burch opened the meeting at 19.03

During the day of the meeting, the CDCC became aware of the police report of a body being found on an Orkney beach and, although formal identification was still to take place, it was thought to be of a local person and condolences were expressed to friends and family.

## 3. Outside Agencies Reports

Katie MacLean, manager for refugee settlement with Aberdeenshire Council, was present in a personal capacity and talked the meeting through the options available for the community:

• Contributing to the Disaster Emergency Committee fund being the fastest and most efficient way of getting urgent aid to people who need it.

- The Homes for Ukraine scheme had just been launched, and has had a large response though, at the time of the meeting, not much written information was available.
- While it might be possible for the community to host, individuals or families, individuals registering to host would be more immediate.
- The Scottish Government was trying to coordinate activities as this can coordinate security checks and checking hosts' premises.
- The correct support for refugees needs to be in place and this could be augmented by the Cullen community – activities at the community centre, making use of local skills, etc.

Cullen Community & Residential Centre would be available to provide short term shelter. Questions were asked about working with intermediary agencies. However, their processes can take months to complete, and a new model will need to evolve. Unlike other refugees who would be looking to make a new life, Ukrainians are likely to want to only remain temporarily and be ready to return whenever possible. The Polish community is very actively involved, has a shared culture and understanding, and can provide natural connections.

And thank you to Katie for agreeing to check the Lintmill defibrillator.

Rachael Barclay (Police Scotland) outlined a quiet spell of calls from the Cullen area but still issues with speeding in certain areas, especially North Castle St.

Simon Tucker (Scottish Fire & Rescue Service) discussed fire safety visits in the community; wildfire prevention including working with local estates where wild camping may be coming an issue; a request that the public pass information about wildfires, such as at the Crannoch woods, to the Fire & Rescue Service or the police; Easter egg hunt, and an upcoming science lesson on venturi principle and atmospheric pressure at work with P7 at Cullen Primary. The crews should be out and about locally with messages for camper vans and caravans.

## 8. Councillors' reports

Donald Gatt spoke about lack of council staff in the legal department to resolve ownership of the Mercat cross.

Theresa Coull spoke about a special full council referring to a report by the accounts commission from Audit Scotland; a Keith visit by Princess Anne; Learning Estates meeting at Cullen Library, a Harbour advisory meeting, and an SSEN storm response workshop. Laura Powell spoke about resilience planning and the SSEN funds available.

## **10.** Planning Officer's Report

Two items of note

• 22/00275/LBC - Proposed installation of permanent light fittings to the ground immediately adjacent to the viaduct piers for illumination of the viaduct structure at Railway Viaduct Castle Terrace Cullen Moray

22/00276/APP - Installation of permanent light fittings to the ground immediately adjacent to the viaduct piers at Railway Viaduct Castle Terrace Cullen Moray

 Modify Condition 1 of planning permission (17/01198/EIA / PPA-300-2052) granting permission for "a period of 30 years from the date when electricity if first exported from any wind turbine within the development to the electricity network (First Export Date)" to granting a permission for a period of 35 years and the Lurg Hill windfarm generation license extension to 35 years.

### **11. Current Business**

a) Harbour Toilets

No progress, but Theresa Coull is hopeful of resolution soon. General dismay at Moray Council not honouring their written commitment to provide at least one public toilet in Cullen.

b) Harbour Users' Committee

The subject of the harbour toilets was raised at the harbour users' committee meeting which Heather Cameron attended on behalf of CDCC. There, Nicola Moss did not provide details on how issues with the lease were being resolved as the issue is "in hand and between landlord and tenant" but did say there is access to water by subscribed harbour users.

Other matters raised at the harbour users' meeting included:

• There are about to be some small jobs undertaken around the harbour e.g. replacing some mooring rings, signage, filling in holes in the pier

- Questions were asked about the yellow hatching in front of the harbour toilets needing to be repainted to reserve access for emergency vehicles Colin Burch to see if it can be added to the other areas that need doing, such as lines in the square, Theresa Coull to check whether this was an action point from the Harbour User's Committee meeting
- Parking on Seatown, where Nicola Moss stated unofficial or unsafe parking was a highway code issue, i.e. police, and not one for Moray Council
- A likely return to face-to-face meetings given that the current restrictions are being lifted on 21 March 2022
- c) Defibrillators

All defibrillators have now got a checking schedule in place: Cullen Square - Friends of Cullen; Lintmill - Katie MacLean; Deskford - Tony. Thank you to all of them. Sandra from Kieran's legacy is happy to attend a CDCC meet to discuss partner working in the future. Suggested a May meeting for that. If agreeable, can contact her to mark in her diary.

- d) Certificates of Recognition Stewart Black hopes to get them printed professionally
- e) Motor home / camper van facilities at Port Long No new activity
- f) Speed Survey A98 outside community centre. A survey has been programmed for this summer.
- g) Millennium Wood

The e-mail trail was forwarded to Brenda Gifford, Chair 3KA, who said the matter would be raised at the next 3KA directors meeting.

h) Logie play park

There is an application into the Money for Moray fund, and this has been shortlisted to give a presentation. Moray Council Community Support Unit are working with the primary school. Primary school pupils have been enquiring about progress and it is hoped it is possible to make a presentation at the school.

i) Cullen Town Flowers

These have not yet been ordered – the cost of ready to plant flowers will be compared the cost of plugs and growing them on.

- j) E-bus shelter Yvonne Joss (Moray Council) has responded and hopes to move the project forward.

As CDCC is, in effect, a statutory extension of local government, free licences are not available to CDCC. However, it would be available to 3KA, and the details have been passed on. It may be possible for Cullen voluntary groups to have a generic E-mail domain name (such as \*\*\*@cullen.org) for their organisation. This would help into the future with transitioning between group administrations with information being held centrally in the cloud.

There is a forum of Aberdeenshire-based stakeholders which includes the Cullen Volunteer Group (not in Aberdeenshire but generous with advice and experience)...'.

b) Scotland's Beach Awards <u>https://www.keepscotlandbeautiful.org/community-and-place/scotlands-beach-awards/criteria/</u>

To gain an award, beaches must meet standards across three areas of Scotland's Beach Awards. These are: Access, Facilities & Safety, Local Environmental Quality, and Communities & Heritage.

Individual criteria points are categorised as 'major', 'minor' or 'best practice'. To gain and maintain an award, beaches must:

- Fulfil the requirements of all Major criteria
- Have no more than three counts of non-compliance to minor criteria
- Demonstrate ongoing commitment to improving best practice

Apart from water sampling, none of this looks insurmountable. However, it costs £300 to apply. Stewart Black to raise the matter at the next 3KA meeting.
