EDU STRAT 2.1	Continue to progress our Moray Education Raising Attainment Strategy with particular focus on closing the poverty related and wider attainment gaps	30-Jun-2022	Planned work for this session complete with planned sessions completed with Education Scotland Curriculum Innovation Team, Scottish Government Insight Advisor, planned work with Education advisors and review of data intelligence and approaches. Work on recruitment for QAMSO network to support moderation in the BGE and roll-out of Moderation plan and strategy with launch event and 65 new QAMSOs recruited from out school system. Senior Phase discussions with Secondary Head Teachers with partnership approaches under review. This will be captured in review of RA Strategy moving forwards as we look to IMPACT Moray next session – Improving Moray’s Performance and Children’s Talents as we consider how best to pull together all relevant areas for improvement and development. Cognisant of key National reviews informing next steps. Stretch Aims setting following ACEL data collection now complete via P+A and awaiting SQA Exam results for this session to further inform stretch aims setting (focus on SIMD Q2/Q5 and Q1/Q5 attainment gap differentials in discussion with Education Scotland and how we close poverty and wider attainment gaps. Initial Education Strategic meeting in planning stages for session 2022/2023 focusing on system wide involvement in raising attainment and achievement and ‘closing the gap’ as identified in data intelligence and revised systems.		
EDU STRAT 2.2	Further build collaborative working across the Community Planning Partnership to support all learners	30-Jun-2022	Partnership strategic meetings and a range of additional meetings to support partnership working are growing with an ever increasing ask of the central team to support a wide range of groups across the partnership. This has an impact on officer time and availability for core education work. Health services have RAG rated their engagement work which is having an impact on Early years and school access to services. Key personnel have changed at different levels which means regrouping needs Next reporting period we will consider the multiple asks and RAG rate this based on priority and level of engagement required from Education.		
EDU STRAT 2.3	Improve data literacy capacity across our system to support improvement in performance	30-Jun-2022	Linked to Raising Attainment, plans for full roll-out of P+A complete with roll-out scheduled for Term 1 by QIM in session 2022/2023. This will include refresh of data mapping, data literacy and refreshed ASG wide attainment discussions/analysis/next steps with QIMs. Scottish Government Insight sessions complete across our system involving messages for next steps to inform Curriculum breadth and delivery. Planning for year 2 undertaken with SG Insight advisor with further sessions planned for next session. Linked with data rigour and improvement plan linked to data, supporting target setting. Curriculum work with Education Scotland team underway, initial sessions including Insight/Curriculum partnership sessions now complete. Next steps planned.

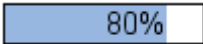



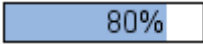

EDU SERV SAL4.1	Develop Supporting all Learners strategy for Moray - contribute to and support ASN Review	30-Jun-2022	The final version of the strategy was presented by SC at LNCT in June 2022 (term 4), following further consultation with head teachers, educational psychologists and third sector providers. The strategy was approved and had been send to the design team to prepare with a distribution date of the 15th August 2022. There will be a paper copy and an electronic copy. The formal launch of the document will be on the November in-service days 2022. Teams are being formed, which included central officers and school staff, with Nurture UK training to deliver the 6 Principles of Nurture to all education and educational resources teams within the 8 ASG groups. This training will be followed up with further training opportunities offered through CPD gateway and e-modules, working in conjunction with Early Years Service and Hazel Sly.	90%

This offer is to also to include how the Child's Planning process will support individual pupils, as well as a curriculum offer for all, linking with offers across Moray and working closely with the Wellbeing co-ordinators and locality groups.	40%

At the time of reporting no further awards have been given to secondary schools. There are a number of schools booking award visits for 2022/23.
