Today is hot and humid with no breeze to blow the fumes away. The paint/solvents cause me headaches and coughing from the solvent getting into my lungs and it irritates my skin due to serious contact dermatitis. There has been air pollution since the unit opened, with toxic fumes entering my house and garden especially when the wind blows this way. Preventing us from enjoying our garden and all our doors and windows have to be kept shut, even in hot weather. The chimney was cause for concern from the start, it is very wide but unusually short - set in the midst of domestic properties, as it is, I am bemused how it was permitted to site such a business so close to our homes. I would like to question how this business was ever permitted to be sited here? Do they THINK they have suitable air filtering - for the staff and surrounding families?Was SEPA involved in the planning before it was approved? There was no problem in the past with other car spraying businesses there, so why now?Can someone from planning dept contact me please to discuss the matter?See the photo on their website - No PPE!!! Posed or not, they have a spray booth, why not use it and look professional?
