## **Council Tenancies - Housing Repairs, Improvements and Maintenance Works**

#### Who we are

Moray Council, Council Office, High Street, Elgin, Moray, IV30 1BX, <u>moray.gov.uk</u> 01343 543451, is a Local Authority established under the Local Government etc. (Scotland) Act 1994. We are the Data Controller of the personal data being collected.

# Why we are collecting your personal data

Moray Council has statutory obligations as a Local Authority Social Housing Landlord, to carry out repairs to Council owned properties under the Housing (Scotland) Act 2001 (amended 2010 and 2014).

When we identify a housing repair, programme of works or a requirement to undertake investigations to establish if any improvement upgrades are needed; we will verify your name and address by cross-referencing it with our systems and will contact you to let you know about any required work.

When you contact the Council to request a housing repair, for example by contacting the Council's Customer Contact Centre, we will collect your name, address and contact details (telephone number and/or email address), and details of the repair requested. We will verify your name and address by cross-referencing it with our systems.

Under the <u>Scottish Social Housing Charter</u> introduced by Section 31 of the Housing (Scotland) Act 2010, the Council, as a Social Landlord must meet set standards and outcomes. These include making sure that tenants' homes meet the <u>Scottish Housing Quality Standard (SHQS)</u>, which includes relevant energy efficiency measures.

### Our legal basis

Whenever the Council processes personal data we need to make sure we have a legal basis for doing so. We understand the Council's legal basis in data protection law to be Article 6(1)(e) of the United Kingdom General Data Protection Regulation (UK GDPR), because your personal data is necessary for the performance of a task carried out in the public interest, or in the exercise of official authority vested in the Council, and the task or function has a clear basis in law. The Council's basis in law is set out under the following legislation:

- Housing (Scotland) Act 2001
- Housing (Scotland) Act 2010
- Housing (Scotland) Act 2014

## Who we share this personal data with

Where we have contractors undertaking inspections, repairs or improvements on our behalf, we will need to provide your name, contact details (e.g. telephone number and/or email address), and property address directly to our contractor. This enables them to contact you to arrange a time to access the property. Contractors and sub-contractors will only use the personal data provided to them to undertake work in fulfilment of their contractual obligations to the Council. We make sure that they manage your personal data appropriately through our contractual arrangements with them.

Anonymised statistical data is shared with the Scottish Housing Regulator, who monitor the Council's performance as a Social Landlord; including the Council's compliance with applicable legislation such as the Housing (Scotland) Act 2001, the Scottish Social Housing Charter and the SHQS.

Personal data may be shared internally with authorised officers of the Council if having access to personal data is a necessary part of their roles, such as to ensure records are accurate and up to date. It may also be shared with other relevant Council departments where applicable.

The Council may share this personal data with other relevant Council departments and third parties, where we are under a legal obligation to do so. For example, this may be with Police, Social Security Scotland, UK Border Agency or other Registered Professional Bodies.

The Council is required by law to protect public funds against fraud. It may share personal data with other relevant Council departments and third parties responsible for auditing and administering public funds, or who otherwise have responsibility for preventing and detecting fraud.

## How long the personal data is held for

Your personal data will be securely stored by Moray Council for a pre-determined length of time. Information is only kept for the minimum amount of time necessary. We maintain a record retention schedule which sets out how long we retain different types of personal data. The Council stores information within the UK.

#### Your rights

Moray Council is the Data Controller for this personal data. You have legal rights about the way the Council handles and uses your personal data. These include the right to ask for a copy of it, to ask us to correct it and to ask us to stop doing something with your personal data. As so far as the legislation permits, you also have the right to request the deletion of your data, and to object to the processing.
