- 3. <u>Police Matters</u>; Sgt Allen gave an update on matters in Keith;

Police officers are monitoring the groups when they gather and taking the necessary action when required.

There was one special service call to assist Paramedics with an elderly lady who had a fall in her home. Two home fire safety visits were also carried out.
