Keith Greener Grid Battery Storage Site – There are plans for the site to be expanded.

KSRP – Kinda Gorn advised that KSRP will become a Development Trust.

Local Concerns – Davie Rough reported the following matters; he was still awaiting a reply from Scottish water regarding the debris that is accumulating against the pipe that crosses the river Isla adjacent to the point where the road bridge crosses the river. He has been contacted by REAP regarding the tidying up of the Glebe land adjacent to the river Isla; he is still awaiting feedback from Diageo about the intended work on Auld Brig.

Roads & Pavements – Phil Eckford advised that the drain covers in the A96 outside the Royal Hotel and Keith Bandstand had sunk and required attention, he is in contact with AMEY about this.

Planning – Stuart Chapman advised that there had been nothing residential recently but there was a submission about the battery storage.

Keith in Flower - D. Borland was not present and Amy Inglis gave the report, Sponsors for the Hanging Baskets were being recruited.

Callum Stuart advised the meeting that the Keith Area Tourism Network meeting minutes of the 26<sup>th</sup> of April contained inaccurate information about Keith in Flower, this was noted.

Keith Christmas Lights – Amy Inglis advised the meeting that materials for the ongoing repair and upgrade of the lights had been purchased.

KCC Defibrillators – Amy Inglis advised that pads in five of the Defibrillators had expired and new pads had been installed accordingly.

Parks & Litter – Neil Kidd advised that a group of residents had got together and litter picked Broomhill Road.

Facebook & Media – Steve Hickin advised that he had been removing unsolicited posts from the KCC Facebook page.

**Cllr Coull** – Keith Grammar School is in touch with Sport Scotland for assistance in returning an unmarked playing field to use as a Football pitch. The street lights at 'The Steppies' have been replaced. The April Walk to School Initiative worked well to reduce school run traffic.

**Cllr Gatt** – There was a Special council meeting for the Moray Development Plan, also attended the Audit & Scrutiny Committee, The Moray tenants Forum and The Moray transport Forum.
