The Chairman welcomed everyone to the meeting.

1. APOLOGIES

Apologies had been received and noted as above.

2. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting of 02 April 2024 were approved.

4. MATTERS ARISING

- a) Newmills bridge work has started and should be completed in next few weeks.
- b) Co-options Andrew Willis, Colin McCarthy. Proposed by Mr C. Soutar and seconded by Mr N Sutherland. Email details to be circulated to Mr C Soutar to add to circulation lists.
- c) Fogwatt ditches Still to be inspected but also dependent on financial support. Update for next meeting.
- d) Roseisle Traffic- Meeting held with council and agreed to look at costs and locations for Vehicle Activation signs and new 30mph signage. Councillor Mustard asked that any other HCC members who have a similar request to bring back to next meeting to understand if there are any cost saving for purchasing a number of the signs for other HCC members. To be added to next meeting agenda.

Roseisle action group— a meeting will be held on 15 May about the traffic issues. The point was raised about the fact that some communities fund their own speed signs, but it was explained that they still need planning permission and also funding for electricity and maintenance.

- e) Elgin Hill roundabout The issue of the water levels at the Belts Road was raised by Mr N Sutherland. Noted that the levels were approaching the roadway and update for next meeting.
- f) Parking at Torridon woods was raised due to the incidence of dangerous parking. This has been caused by the lack of payment facility in the area as machine works on an App which people do not have access to and reduced mobile signal in the area. Chair advised that this should be reported to the local Police as HCC had no remit in this respect.

Correspondence.

- 1. Common Energy, Moray Apologies but I don't really understand what next steps are?
- 2. Cloddach bridge- business plan approved, and next step is that it is now waiting for Ministerial approval. Mr C Soutar is looking for Fairhurst invoices for HCC finance purposes and agreed to pick this up with HCC treasurer to ensure we meet our accountancy obligations. Bring back to next meeting if required.
- 3. Rothes open day was fully booked and a number of the HCC were unable to obtain tickets. (*Chair to mention at next meeting with Rothes?*)
- 4. Elgin long term plan £20 million available for public projects and Chair encouraged members to log in and vote for/ create proposals for the use of funding.

5. SSEN consultation – next meeting due 5th June 2024 to discuss the locations of the new line and impact in Dallas, Kellas and Fogwatt. (*Not sure that I picked up the subtle nuance here? Or what it was raised for.*)

Chair reminded the group that this was not in the purview of HCC. Mr A Lyons asked that the issue was placed on the next meeting to collate any other occurrences which he would raise directly with BT The Chairman thanked everyone for attending the meeting, especially for the increase in members of the communities who were now attending and contributing to the meetings.
