### Welcome:

MR welcomed everyone and declared the meeting open.

MR proposed that the Planning items be taken after the Business section. This was approved.

## **Guest Speaker: Inspector Neil Morrison**

This was the first time that Police attendance had been possible at a meeting of Speyside Community Council. We hope that it will be the first of many.

Inspector Morrison, Police Scotland provided an overview of Police Scotland's day to day operations within Moray. Lack of resourcing leading to cuts in police and civilian numbers was highlighted and discussed by those present.

Speeding in our communities was raised and Inspector Morrison explained the reasons why Police Scotland will not support Community Speedwatch initiatives.

Some personal experiences of engaging with the Police were discussed and Inspector Morrison's advice was both supportive and constructive. The issue of

keeping Fleming Hall intruder free, during opening times, was discussed. The Crime Reduction Officer will be contacted to conduct a survey of the building and make suggestions as to how to make it safe. This was welcomed by those responsible for managing Fleming Hall.

Inspector Morrison was thanked for his input.

### Matters arising and not overtaken on the Agenda:

**Rothes:** Speeding data – southbound – average speed is 31.4mph. As this is the average speed, some vehicles must be going considerably faster. Speeding is a police matter.

MR still has to contact Land and Parks re: schedule for maintenance to the bridge over the Burn of Rothes.

Planning Matters –

24/00426/APP: MOT Building, Rothes. SCC submitted a representation requesting a change of cladding to make the building look less industrial. Request to be made to Rothes Council to amend its Minute to remove the word 'Objection' and substitute 'Representation'.

Greens of Rothes: 21/01903/EIA Installation of a pipeline to the R.Spey. This application has been withdrawn as it has been superseded by 23/02089. The waste water will now discharge into the burn rather than the R.Spey.

**Aberlour:** R2 Speyview: no new developments. However, the speed/volume of traffic strips are in place at the top of Dowan's Brae.
