- 1. **Welcome** Vice chairman JT welcomed all to the meeting, chairing in the absence of PGD who is not available this evening and thanked all for coming
- 2. Apologies PGG
- 3. Guests Speakers – John Mundell – Interim CEO MC – commented he was in attendance to see how SCC was running and to generally catch up. Harry - Police Scotland - update on current and ongoing challenges and antisocial behaviour in the Strathisla area and answered questions from Community Councillors. Kevin - Fire Service - currently 7 retained firefighters, looking for more, no age limit, must pass fitness test. Wealth of experience in current staff. Callum - Ambulance Service - Keith has a single Ambulance 24 hour cover, staff by either 1 or 2 on 12 hour shift. Difficulty getting out at Turner Street – ThC will look follow up. No 24 hour fuel access in Keith causes difficulty for refuelling. Joint comment from all services - work together in visiting schools and giving presentations to raise awareness of various issues and problems that the pupils may encounter. The housing for all 3 services have different drawbacks, lots of office space but restricted parking for Police. Poor access and lighting, few facilities and lack of inside and outside space for Ambulance service and restricted access and facilities for the Fire Service. All thought the provision of a joint site with the appropriate space and facilities would enable much better working practices and more closely integrated services to be provided. Often when one service is called, it requires the attendance of at least one of the other emergency services. JT thanked the Service personnel for taking time to contribute to the meeting, they are always welcome to attend
