1. APOLOGIES

Apologies had been received and noted as above.

2. Common Energy, Moray

Alex Walker provided an overview.

They have been in discussions with EDF Renewables in relation to their Clash Gour Wind Farm proposal. There was a conference in 2019 in terms of potential investment into the project in terms of funding routes etc.

This is a 48 MW project.

Potential to invest up to 10% which is circa £10m

Planning was approved in Oct 2022

They have received funding for professional advise and are seeking potential Community Share Issue in the future.

They have a Board of Directors

Project is still in the early stages in terms of their potential investment.

EDF have still to confirm financial commitment to build the Wind Farm

Community benefit is not part of their overview / involvement

3. MINUTES OF THE PREVIOUS MEETING

4. MATTERS ARISING

- a) Fogwatt Ditches. Still to inspected. Councillors to provide update either direct to W Duncan or at the next meeting
- b) Roseisle Traffic . No update, agreed to discuss at next meeting
- c) Water levels at Belts Road. No action has been undertaken and with the recent increase in rainfall there is likely further erosion. Councillors to provide update at next meeting.
- d) broadband. Roseisle Main Road will complete Mid Sept.
 action agreed that we would review areas that are not currently covered by Broadband within Heldon and we would produce a map of the outstanding areas for further discussions with Openreach



5. CORRESPONDENCE

Most correspondence had been circulated to all members but some might need further action.

- a) Wind farm update. Suggestion that we could receive funding on an annual basis though requires to be kept in a high interest account.
 Further discussion required Rothes III 24 turbine potential commencement during 2025. They are re-apply for planning due to a change in blade sizes. Further discussions with Fred Olsen on fund allocations.
- b) Findlay path fund. Per email, fund applications now available <u>https://www.pathsforall.org.uk/ian-findlay-path-fund</u>
- c) Proposed development comprising a battery energy storage system (BESS) with associated infrastructure with capacity up to 49.9MW on Battery storage facility at Loanhead Farm pre planning notice submitted.

There is a public exhibition at Spynie Hall which was advertised within Northern Scot.

- d) Elgin area learning estate. A Sustainable Learning Estate questionnaire is currently on line and closes Friday 28th June 2024. Questionaire located upon Moray Council web page
- e) S.S.E.N. update. Route is now being formalised

• Biomass project at Fogwatt is still on the Council planning portal and new client documents have been uploaded.

8. A.O.C.B. to include area reports

- Miltonduff replacement village fence will commence 15th July as now obtain road permit and traffic lights to enable works to commence.
- Cloddach Bridge Council has advised the next steps, Once ministerial sign off they will prepare the tender documents and tender the work as a design build contract. This process is likely to be complete in October/November, after which the contract will be awarded and the detailed design and statutory consent process can begin. Following tender a programme for construction will be established.
- Viewhill bridge works are progressing with anticipated completion end of July.
- Verges Concern on verges in and around Birnie, though this is a wider concern for visibility for cyclists.
