5.	a) SID funding update – JD had emailed members with costings for SID units which she had received from Colin Matheson of Moray Council. CR is awaiting replies from Brian Love and Grant Nicolson regarding quotes for placing posts for the SID units. Both of these are on the MC approved list. Brian Love is confident he can beat the MC quote of £738.36. KR confirmed that the SID unit will require to be fitted to a separate post and not placed on an existing lamppost.	CR
	There followed a discussion about whether or not DLCC will be able to claim back the VAT for this project. LC will check with procurement to see if there is a way we can do it without having to pay the VAT. It may be better to do one at a time so that the work costs less than the £5000 limit. Dyke Primary School Parent Council held a bottle stall at the Forres Toun Mercat on Friday 7 th June and raised almost £200 which they will donate to our fundraising for the SID units for the village. 	d) Bank Account progress — ST went into the Banking Hub in Forres as suggested by PM.
