2. MINUTES OF THE PREVIOUS MEETING

3. MATTERS ARISING

- a) Loanhead Battery Storage. They have been asked to attend the next HCC meeting on the 10th December as part of the PAN process, though awaiting confirmation of attendance
- b) Cloddach Bridge update. Moray Council are awaiting further information from the UK Department of Transport which is being held up with the new Government who are understanding a full review
- c) Berry Burn Public meeting is being held 30/10/24 at Dallas Hall. The proposed borrow pit is not suitable and are seeking alternative locations
- d) Moray Learning Estate On line meeting on the 11th November between 2 -3 & 6-7pm briefing session on the outcome of the Elgin ASG survey and next steps
- e) Pre-aplanning procedure. HCC no requirement to provide consultee response
- f) CC Finance. HCC have provide information on our yearly running costs. CC process being presented to Moray Council committee in December
