



# Grass Cutting application form

If you meet the following criteria and agree to pay the amount stated for the Grass Cutting Scheme, please fill in this form.

The Grass Cutting Scheme is available to Moray Council tenants, who meet the following eligibility criteria:

- ✓ they are a Council tenant with sole responsibility for maintaining their garden; **and**
- ✓ they are not able to cut their grass due to a recognised substantial and long-term illness, physical or mental health disability as defined by the [Equality Act 2010](#); **and**
- ✓ there is no other **tenant** living with them who is able to cut the grass (please note this does not include other members of their household who are not tenants); **and**
- ✓ they are in receipt of any physical or mental health related benefit. Examples include Personal Independence Payment (PIP), Adult Disability Payment (ADP), Pension Age Disability Payment (PADP) and Attendance Allowance. We may ask for evidence to confirm the receipt of benefit.

Eligible tenants will have their grass cut up to 10 times between April and October.

The cost for the Scheme is £298.56 (£248.80 + £49.76 VAT). Eligible tenants who get any of the following benefits will pay £144 (£120 + £22 VAT) per year:

- Universal Credit
- Pension Credit
- Tax Credits
- Working Tax Credit
- Housing Benefit
- Council Tax Support
- Child Tax Credit
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Income Support

If you are accepted on to the Scheme, we will send you a bill which will explain how and when to pay, including options to pay by instalments.

If you do not pay the amount you owe by the end of the grass cutting season:

- we will take debt recovery action against you; and
- you will be refused registration next year.

**Tenants must apply for the Scheme each year.**

#### **Definition of disability under the Equality Act 2010\***

You're disabled under the Equality Act 2010 if you have a physical or mental impairment that has a 'substantial' and 'long-term' negative effect on your ability to do normal daily activities.

#### **What 'substantial' and 'long-term' mean**

- 'substantial' is more than minor or trivial, e.g. it takes much longer than it usually would to complete a daily task like getting dressed
- 'long-term' means 12 months or more, e.g. a breathing condition that develops as a result of a lung infection

#### **Progressive conditions**

A progressive condition is one that gets worse over time. People with progressive conditions can be classed as disabled.

You automatically meet the disability definition under the Equality Act 2010 from the day you're diagnosed with HIV infection, cancer or multiple sclerosis.
