3	I am sorry I am unable to attend the drop in session at the Forres Academy 21 October but would like to leave my comments here about the new site. The Lochyhill site seems the ideal place to build a new school. Pupils from the surrounding villages get there easier by bus, and parents would have no need to ferry children in individual cars. Pooled bus services are lowering the emissions, and the town would no longer be in gridlock between 8 and 9 am and in the afternoon. Forres has expanded considerably in the past few years. The impact on the infrastructure and natural environment is still to be evaluated. We need our common land green spaces more than ever. Elgin Academy seems perfectly well situated at the edge of town. I live very close to the present Academy and the stores nearby and I can observe daily the comings and goings. When I was still physically able to get down the banks of the Mosset Burn I was part of the litter picking group. This has all ceased to exist. The whole area around the banks are a tip. Plastic litter has been blown about, accumulating; it slowly gets covered up somehow by green summer growth and looks horrendous in winter. I wonder how many wildlife choke on the debris. The footpath between the two shops does not ever get cleared of litter and weeds. Accidents happen on the footbridge with cyclists, dogs, prams, mobility scooters and foot passengers all meeting at the narrow bridge edges, but worst when dozens of pupils try to get over the bridge 4 times a day. They are released to do their shopping for mid morning and lunch breaks.Nobody teaches them to take their litter with them. The bins are overflowing or get overturned. Old folks cannot do their shopping at school times because of the long queues of hungry kids. That is also true for other shops and supermarkets in town at lunch time. But what do pupils get to eat? A bag of crisps, a sweet bar and maybe a sugary drink. The more affluent ones can buy chips or burgers. 6	 I filled in an online consultation a week or so ago. Presumably Survey Monkey has my response. However, having attended a meeting on this topic at Forres Academy two days ago, when it was made clear that ONLY comments to do with Common Good Land loss will be considered relevant, I wish to do the survey again. What are your views on the proposals in relation to Roysvale Park?• Do you have any views on the potential benefits of the proposals? In my opinion, the so-called potential benefits are very unlikely to prove genuine. During three or more years of the proposed New Academy construction, half of Roysvale Park Common Good Land will be lost. After construction, a third of the park will be lost permanently. A small football pitch will be left but there will be no room for a grass athletics track, which is currently used by Academy pupils and Forres Harriers. A tiny pavilion will be of little use to anyone apart from footballers. With advancing Climate Change, the proposed 'improved drainage' will prove to be impossible to achieve. As for 'improving the traffic flow' this will prove to be impossible.  The proposals are vague and incomplete, and misleading, as we have not been given enough detailed information. You need to show the whole picture - how Roysvale is in the middle of a split school campus, and therefore will be absorbed by the school, and no longer be attractive or available to the community. The reality is that Roysvale Park will NOT be returned for public use. Dog walkers will have to be stopped from exercising dogs (due to fouling), in an area which is to be taken over as a school playing field for the academy pupils, and presumably for Applegrove Primary pupils as well. A ridiculously small area for 2 large schools to be using, let alone the community. The feasibility study that recommended Roysvale as a site has several inaccuracies. (This begs the question, "was it the fault of the producers of the feasibility study, or the fault of the brief they were given?) The feasibility study on which the council based their site decision, states that : "The new school, on any of the potential sites, will be within a single boundary". When I asked Shona ? (Project Manager) about this on 2 occasions, she answered that roads dept would sort that. Therefore how are TMC so sure this will ease traffic flow if we are still awaiting planning and roads reports?	
There is also an entrance to Applegrove Primary school where the buses will emerge. Although Learning Estates spokesperson didn't know yet which direction the buses would be going. How can people make a decision without knowing where the traffic will be going?

We also were NOT informed of the exact size/ dimensions of the construction compound, although Andy Hall assured us that it would not exceed that area on the image provided. How is he able to say that without the actual measurements? If he has the measurements, why are they not in the public domain? And who will police all those assurances we are given?	
How will the construction compound be accessed, and how will vehicles from the construction compound access the building site? It's not shown on the diagram. This is important for people to assess the risk to primary children, and to let the community know which and

The proposals are CONTRARY to current guidelines which advise making more accessible green spaces in towns, and in dense areas of housing and business on Orchard Road, around Roysvale Park. These valuable spaces are irreplaceable and good for our health and well being.	
I quote Moray Councillor Draeyk van der Hornin the Forres Gazette: "Access to green spaces and clean air alleviates stress and encourages physical activity, while environmental degradation leads to health issues and higher health care costs." However Councillor Horn's words do not match his actions nor TMC actions. Both the Applegrove primary school pupils and the community are being robbed of green space.

It is INSULTING to the Forres community to ignore their wishes to have the new academy built at Lochyhill, their wish to leave Applegrove Primary School with their playing field, AND the community with Roysvale Park as the lovely tree lined green asset is is for Forres.	
It was also INSULTING to the Forres community to provide such a poorly organised drop in session at Forres Academy with such a lack of information. Two representatives of Learning Estates were nowhere near sufficient to deal with the amount of people who	
attended. TMC are well aware of the opposition to their proposals, and could have been better prepared.	

There was insufficient information available. We were told that our queries would be answered "in planning stage", yet TMC are expecting the community to base their decisions (yet again) on too little information. People were leaving in disgust as they couldn't hear what was being said, and couldn't get near to ask questions.	
People were commenting that this was just another tick exercise for TMC. The images sellotaped to the backing boards were too small, and kept falling off.

There are NO potential benefits to the common good land from concreting over a green area to construct a bus /car park, and using the remaining diminished common good space as a sports field /playground for 2 large schools, and a walkway between school and carpark for staff and pupils.	
 3. Do you have any issues arising from the proposals. - My fear is that our representations are to be summarised, and reported to the next committee by Learning Estates (Andy Hall or Shona ?). How can this be an OBJECTIVE report when Roysvale/Applegrove is Learning Estates' preferred site for the Academy, therefore change of use of Common Good Land is in their interests? 	
-Why is Forres not getting a school on the edge of town with a proper campus within one boundary as the feasibility study recommended, like most other new schools in Moray? It seems Forres are being short changed on many levels, by taking common good land to facilitate squeezing a new academy into an unsuitable site. It is unacceptable that Learning estates still hadn't established the ownership of the land at Lochyhill in October 2024, when Denise Whitworth committed to preogressing the Lochyhill site along with Roysvale.	
 where is the money for the footpath and drainage (management proposals) for Roysvale coming from. Is this coming out of the new academy finance? I would like to see the tree survey. That should be in the public domain. 	
4. Do you have any additional comments? If TMC were representing the majority view of Forres community, and building at Lochyhill, there would be no need for costly, delaying court procedures. The young folk of Forres deserve better.	
What guarantee do we have that this is not the start of a 'land grab' of Roysvale by Moray Council? They have already decided to use the common good funds as they wish. And clearly they need Roysvale Park as part of the new school campus.	
We are not being told which trees will be cut down. Why? The council must know by now.	
Time and money is being squandered on unnecessary court proceedings, and planning excessive flood alleviation measures, whilst pupils'education is suffering, and will continue to suffer in the next 3-4 or more years while heavy construction machinery operates immediately next to a primary school with special needs children likely to suffer most. 	bus lane, which will mean there is less space available for the public to use for sports or other activities. If it is not a significant distance to walk (for others), why can the buses not use a bus lane located near the old school or the old school car park? Please preserve as much of our park as possible.	Your points regarding the reinstatement of common good land and the safety of the bus lane would be considered as part of both the detail design and planning process.
	I also do not agree that a second path is needed. There is already a path running around 3 sides of Roysvale - this is adequate. A further path will add more cost and will also reduce the size of the park.	I can confirm that the drawings displayed at the drop in event and available online as art of the full consultation document are to scale. I would also note that the drawings detail that the football pitch would be retained with a 200m running track available
	I am concerned that siting building works on the common damage will cause irreversible damage. The path that was previously constructed used a corner of Roysvale adjacent to Applegrove and Sanquhar Road and	during construction and a 300m running track available after construction.
	has never been returned to its former state. I worry that construction use will cause permanent damage to the park.	Lastly, the proposal detailed that it would look to retain (or replace as required) all of the well established trees. A tree survey has been undertaken and the outcome will be used to inform the detailed design process.
	I do not think the planned bus lane will be safe. An entrance / exit close to the Nelson Road junction will be located on a blind corner and will also be right next to the existing road crossing and also the entrance gate to Applegrove Primary. This is already a dangerous crossing and cars often come around the bend too fast	
	and in the middle of the road. I am concerned a serious accident will occur and a bus lane in this area will increase the risk. There is also insufficient space at the swimming pool end of Sanquhar Road and I cannot see how this will allow buses to turn safely. The roads in this area are already very congested in the	
	mornings and as stated above, it would be better for the buses to come off the road and continue to use the old school ca park or an alternative bus lane area.	
	I am also concerned that the plans shown at the public meeting were not to scale - this gives a misleading impression to the public if this is the case - can you confirm whether this was the case or not please?	
	If the path and bus lane do go ahead this would surely reduce the area of space available such that the existing running track and football pitch would no longer fit - this is a very well used public area: kids and adults use the football pitch regularly and the running track is also well used by the public and the school. Roysvale is also the main green space area for the Sanquhar area - all other areas of Forres have an area of green space to use - please preserve this area for all of the people who use it.	
	Finally, I am concerned about damage to the trees that adjoin the Applegrove playground and also bordering Sanquhar Road. These trees add to the natural beauty of the park and make this an attractive green space for everyone to use.
