Minutes from the Meeting on Monday 02<sup>nd</sup> December 2024

**3. Adoption of the Minutes of the November 2024 meeting**

The Minutes of the November 2024 meeting were adopted as amended - Proposed by D. Borland, seconded by A. Inglis.

**Additional Item:** The Chair welcomed 7 year old Bella and her grandmother Jennifer Cruickshank, to the meeting and gave them the floor so Bella could make a statement in support of Keith Library to the Community Council and Ward Councillors present. At the end of her statement Bella passed a petition in support of keeping Keith Library open to Cllr Gatt for the attention of Moray council.

**4. Police Matters:** Sgt Mackay advised the meeting that the police community report will no longer be issued monthly and will be issued quarterly. There have been no major issues in Keith last month, the local police have been carrying out intervention work with the S2's at Keith Grammar school, the parking initiative in Keith is on hold for the time being.

*Parking issues at Broomhill Road/Banff Road;* The situation seems to have improved after the Keith Fire Station Watch Commander spoke to local residents about the difficulty for Fire Appliances accessing Broomhill Road – the police will continue to monitor the situation.

*Parking issues in the car park behind the old TSB building in Mid Street;* A badly parked commercial vehicle is causing an obstruction in the car park.

## 9. Watch Commander Keith Community Fire Station

Watch Commander Kevin Mitchell gave his report for November; it was a very busy month for Keith crews with a total of 23 fire calls. There were 12 false alarms, 6 fires – Chip Shop in Dufftown, House fire in Huntly, wheelie bin fire in Keith, an unattended controlled burning at Newtack, a car fire in Keith and a garden fire a Gartly (which was a neighbour dispute).

Five Special services calls; 3 assisting Paramedics with elderly patients who had fallen and 2 assisting the police to gain entry to property.

Visited the new battery storage site at Netherton with members of KCC and a representative from United Keith, this was a very informative visit which was well met by The attendee's.
