### Forres Local Place Plan - 'By the Community for the Community'

#### **Foreword**

This Local Place Plan (LPP) will be submitted to Moray Council by Forres Community Council with support from the Forres Area Forum, Forres Area Community Trust and Forres Community Sports Hub on behalf of the residents, businesses and visitors to Forres.

This Local Place Plan (LPP) has been produced as a continuation of our community action plan Spirit of the Community (2024 – 2034) which was launched in 2024 and sets out the aspirations of the community for the whole of the Forres ASG area.

An additional consultation took place later on in 2024 to fill the gaps that we felt required more depth and greater input in order to complete an LPP.

This LPP sets out the ways in which our community wants to see land developed and used and a spatial vision for our town.


The LPP is a way of identifying and helping to deliver community projects and provides information for other interested organisations. We hope that it will encourage more collaborative working to enable a positive outcome for the continued improvement and development of the Forres Community.

The LPP has demonstrated regard to Moray Council Local Development Plan and the National Planning Framework 4 (NPF 4). We confirm that it aligns with policy aims and objectives of Moray Council Local Development Plan 2020 and NPF 4 and is not seeking to amend the MCLDP 2020.

This LPP will be published online, alongside our community action plan, Spirit of Community (2024-2034) and will be shared with local community groups. It will cover a period of 5 years from 2025-2030. Forres Community Council will work alongside partners and community to help achieve the goals and aspirations.

# 2. Introduction

The Local Place Plan area is defined by the boundaries shown in the Forres Community Council Map



#### **Aims**

The aim of this plan is to give local people a say in future development decisions in Forres.

Our objective when producing this plan was to have a place-based plan that reflects public consultation and meets the LPP criteria to inform future planning decisions via MCLDP 2027.

The Forres Community has inherently been a most pro-active community with the vision and drive to improve all aspects of the community: to create a better place, to attract new residents, to support local businesses and to support the formation of new community groups to enhance the local economy and environment.

## A snapshot of our area

## Population & Households:

There is a higher proportion of one-person over-65 households in Forres compared with that of Moray and Scotland. Having a higher rate of elderly residents living alone is likely to put more pressure on Health and Social Care services.

### **Transport & Active Travel:**

The A96 links Forres to Inverness and is serviced by a number of bus routes. Forres train station provides links from Aberdeen to Inverness including a direct Inverness Airport link since 2022. There is also an established and growing network of core paths and designated cycle routes throughout the area. There is a larger proportion of households with no vehicle in this area compared to the Moray average. This makes it important to have strong local transport services.

## Young People:

Forres has a slightly lower number of 16-17 year olds in full time education than the rest of Moray and Scotland, indicating that pupils are leaving school early and either entering or seeking employment or training. The unemployment rate for younger people in Forres is higher than national and Moray levels. Child poverty is a prominent social issue in the area.

#### **Education:**

Forres is served by one secondary school, Forres Academy, which serves the whole ASG. 3 of the 8 feeder primary schools for the secondary school are within the LPP area, Anderson's, Applegrove and Pilmuir. At the current time, Moray Council is undergoing a Learning Estate review.

This means that a number of engagement sessions and focus groups have been held looking at the current school buildings in the area and how to improve their sustainability in the future. The design and build of the new Forres Academy is expected to be completed by December 2027 although at the moment no build has begun.

#### Health:

The Forres ASG has two medical practices, Culbin and Varis, both based in Forres Health and Care Centre providing NHS primary care services and host a variety of community health and social care teams. The area has a number of pharmacies and specialist health services. Mental health continues to be a growing health concern in the area.

## **Employment:**

Those economically active in full time employment has reduced over the years, though those in part-time work has increased. This statistic could be related to increased caring duties. 259 (2.6%) of residents in Forres provide over 50 hours of care per week, which is higher than the Moray rate and fractionally higher than the national rate.

## Heritage:

Our area has a diverse heritage including Forres's links with the real King Macbeth, the monolithic Sueno's Stone found at the east end of Forres; a 21 foot Pictish carved stone and Nelson's Tower sits at the top of Cluny Hill.

Forres is the start of the Malt Whisky trail with two distilleries attracting visitors to the area, supporting economic growth and development along with the businesses now located in the Enterprise Park, all helping to increase job opportunities and assisting with the retention / attracting the younger age group to the area. ## Social & Community:

There are numerous churches, historical buildings, and community buildings in Forres including Forres Town Hall, Forres House Community Centre and Library, and a local swimming pool which are used by many groups including Youth Uniformed Groups, Men's Shed, Air Training Corps, Army Cadets, dance, pipers, social, toddlers and youth volunteer groups.

The area is known for its plentiful community groups offering opportunities for all users.

## **Environment:**

The Forres ASG area is well provided for with green spaces, many of these located within housing areas. Forres has been a constant winner of the Beautiful Scotland and Britain in Bloom awards thanks to local group, Forres in Bloom.

There are also many other open areas which can be easily accessed to enjoy the local environment including the Dava Way, Culbin Forest, Sanquhar Woods and routes that link into the Moray and Coastal Ways.

## **Community Engagement**

While engaging with the people of Forres was key to producing a Local Place Plan, the Forres area local action plan, Spirit of Community was completed in early 2024 after extensive engagement and we wanted to draw on data received through that process. In the last few years multiple ongoing initiatives have reached out to residents for their thoughts and ambitions. Our intention is for the results of these consultations, and others, to be fed into this Local Place Plan.

Forres LPP 2024 is the result of study of the guidance and policies available to us, and of our local consultations.

## Mapping exercise

We held a meeting to map where current priorities from the Spirit of Community Plan sat on the local living wheel. While this isn't exhaustive it gave us a good indicator of the current situation. **Appendix 1.**

## **Involving the Community**

The first meeting of the Spirit of Community engagement group took place on 31<sup>st</sup> January 2022 and included representation from the following community groups, organisations and agencies:

The group collaborated on four separate engagements:

April 2022- A public engagement event at Forres Town Hall where 80+ attendees participated.

April 2022 - Online Survey Monkey where 119 responses were received

Following analysis of initial feedback, young people were recognised as a gap in respondees; the following targeted consultation was undertaken as a result:

Autumn 2022 - 163 responses from Forres Academy senior pupils engagement

Autumn 2022 - 76 responses young persons' focus group

March 2023 - at Forres Academy and FACT's Employability Project- an additional 23 participants took part.

May 2024 - At the launch of our Spirit of Community Plan we asked attendees how we could best collaborate to progress some of our identified priorities.



We asked attendees to name groups that could support priority actions, projects that already fitted well with the themes and any barriers they were aware of.

We also asked how best to progress priority actions and the general consensus was thematic group meetings followed up by 6 monthly updates – 40 attendees.

Following on from the May 2024 launch of the Spirit of Community Plan the opportunity to produce a Local Place Plan was identified. Subsequently Forres Community Council, Forres Area Forum, Forres Community Sports Hub and Forres Area Community Trust (FACT) met to discuss further engagement that could support the production of an LPP while utilizing the substantial amount of engagement already done.

Oct 2024 - we promoted a community wide online survey that received 59 responses. **Appendix 4** 

September 2024 - We hosted a pop-up stall at Moray Pride in Forres's Grant Park that received 30 responses Appendix 5





July 2024 We hosted a stall at one of Forres Town Hall's Coffee Mornings

July 2024 We had a session to engage with young people. **Appendix 6** 

As part of our consultation process for both Spirit of Community and the Local Place Plan we asked people to identify the strengths as well as the challenges or weaknesses within our area.

## **Strengths**

People enjoy living in Forres for its strong sense of community, friendly atmosphere, and beautiful natural surroundings. The town offers a peaceful, rural feel with easy access to green spaces, woodlands, and beaches.

Locals value the area's safety, low crime, and clean environment, as well as the variety of activities, from local events in Grant Park to scenic walks up to Nelson Tower. Forres is rich in culture and history, with a unique charm enhanced by floral displays, historic sites, and a range of cafes and shops.

## Challenges

While new affordable housing is welcomed, continuous housing developments are perceived to strain local resources without sufficient infrastructure improvements.

Residents find Forres lacks infrastructure, including inadequate public transport, long travel distances for specialist healthcare, and a poor road network with frequent traffic delays.

Parking is an issue in the town, with insufficient spaces and restrictions which can't be enforced due to lack of staff resources within Moray Council, this causes safety concerns.

Maintenance issues, such as deteriorating buildings, uneven hard landscaping and street furniture in need of repair detract from the town's appeal.

Local residents and young people expressed that the current secondary school is not fit for purpose and a new secondary school is needed as a priority. While a new secondary school is in development there is concern that delays to decisions on the site will impact the proposed timeline.

Young people perceive that there is a lack of facilities and provision for them and often feel left out of decision-making processes.

Moray Council is perceived to be a financially challenged local authority.











## Theme 2: Traffic, Transport and Access

Members of the community were looking for improved transportation infrastructure and connectivity including rail frequency, realistic routes, timings, cycle links and pedestrian safety.

Issues around the safety of crossing the A96 especially to access rail travel were seen to limit opportunities for work and visitor economy. Lack of parking is perceived to be a cause of traffic congestion during larger events. Those residents requiring specialist health support are negatively impacted in terms of finances and their mental and physical wellbeing by travel to Aberdeen and further afield. There is support for satellite specialist healthcare provision in Forres to counter this and the impact on the environment of many patients travelling for care versus one specialist travelling to Forres to provide a clinic. There were suggestions this could link to plans for the former Leanchoil Hospital but this would need to be discussed further.







One comment requested looking at the formatting of the plan on different devices which the steering group did and decided that a pdf of the approved document would be the best option.


One comment requested slight changes to wording indicating that parking issues remain under the jurisdiction of Police Scotland currently, not Moray Council, which we amended.

A session in Forres Academy took place at the end of June 2024 with 14 young people, supported by a guidance teacher. The session was facilitated by the Community Support Unit officers and a local GP and the focus was on good health for young people in Forres.

Although the focus was on health to incorporate findings into the HSCM locality working group, there was a much wider discussion about the Forres area and how lack of facilities and spaces was impacting young people's health. The information was anonymised and shared.

Their recommendations are below

Support for a new school with increased facilities and subject choice so that travel to other high schools for subjects was not required.

Access to Facilities: Improved maintenance of facilities like the Sanquhar pump track, basketball court and increased access to facilities through new provision eg skatepark.

Transport Solutions: Develop better transport solutions for rural areas to facilitate social connections and access to resources.

Safe Spaces: Create more safe spaces for young people, girls and other marginalised groups within schools and communities.

Youth Involvement: Involve young people in local decision-making processes and ensure their voices are heard in community initiatives. Potentially themed groups at school based on challenges e.g. transport - Where young people could invite decision makers for Q&A. Themed/opt-in groups were preferred as not all young people are affected by the same issues

Life skills: Offer cooking classes, money management and promote positive life skills beyond academia in both school and community settings.

Healthy Food Access: Explore initiatives to make healthy foods more affordable and accessible. E.g. Fresh fruit at school from local initiatives and access to local food growing initiatives.

Inclusive Events: Organise more affordable local community events that cater to a wide range of ages and interests and involve young people in planning.
