- **Planning Updates:** \*Hydrogen Plant, Marypark, Ballindalloch  
SCC submission to Moray Council was circulated to members.  
There are currently 355 objections and 6 in support.  
Spey Fisheries Board has objected.  
NatureScot has also objected but has requested further information.
- **Shared ownership offer from Teindland Windfarm - MOU:**  
\*It was decided not to pursue this offer.
- **EDF Renewables/Macallan Solar Farm:**  
\*Information previously distributed.
- **Licensing:** \*Glenfiddich Distillery, Premises Licence Application.

Cllr Gordon requested that 'Overnight stays for campervans/motorhomes' is added to the Agenda for the next meeting.

**Business:**

- **Amended Terms of Reference for SCI:** It was agreed that MR/NS would add an amendment to the existing Terms of Reference that would protect equipment and money belonging to SCI and bring it back for ratification at the next Community Council meeting.
- **Planning for Community Council Elections:** CC elections take place later this summer. SCC will be asked to contribute approximately £100 towards the cost of these elections. Whilst Moray Council will organise the election process, CCs are expected to play their part.  
It was suggested that SCC's profile could be raised by attendance at the Aberlour Games, articles in The Rothesian, Kirk News and local newspapers and use of Social Media platforms.
