6. Co-option

10. Confirmation of Annual Grant

The CCLO informed members that the annual grant for Elgin is £2299.96 for the period April 2025/2026.

The grant is calculated at £500 plus 0.0725 pence per head of population, the population for the area is 24827.

The annual grant paid is distributed in two parts, April and October; the second grant payment for the period 20225/26 will be paid on receipt of examined annual accounts. These should be submitted as soon as possible.
