## 6. Adoption of Constitution

# 7. Agreement of Meeting Schedule

The current schedule was suitable for all members and was agreed to continue. Meetings held on second Wednesday of the month, no meetings in January or July. It was noted that community councils had to meet a minimum of six times per annum. It was agreed to schedule ten meetings per year and if a meeting was not required it could be cancelled. Meeting venue would remain the church hall and time would remain 7:30pm.

# 8. Banking Arrangements

Current signatories had returned as community councillors.

#### 9. Confirmation of Annual Grant

The CCLO informed members that the annual grant for Dyke & District is £563.8 for the period April 2025/2026.

The grant is calculated at £500 plus 0.0725 pence per head of population, the population for the area is 880.

The annual grant paid is distributed in two parts, April and October; the second grant payment for the period 20225/26 will be paid on receipt of examined annual accounts. These should be submitted as soon as possible.

A question was raised about the work that had been undertaken by the JCC admin grant sub group. A meeting had been held in August 2024 to discuss various options to propose to Moray Council for distribution of the administration grant. For various reasons this work had stalled. However, the sub group had met in September 2025 to make proposals. There had been no clear majority from community councils about a preferred option. A full report would be taken to the next JCC meeting.

# 10. Communication and Engagement

CR and NM were admins on the Facebook account. A lot of communication was received through Facebook Messenger. It was discussed how to get represtation from the Darnaway area.

# 11. Business from previous meetings

The CCLO closed the inaugural meeting and handed the meeting over to the new chair to start Community Council business.
