{2}Parking - The parking on West at where the burger van / property is and where the cars/vans/lorries park ie, on the bend at the bridge on pavement along the street leading to High Street taking up all available parking which near by residents then find it an inconvenience when they may have been shopping and cant get parked near to their home to take in the shopping in

{3}Road Safety- To the best of my knowledge there seems to be a total disregard to road safety for the safety of road users and pedestrians which use the pavements and roads , it is my belief that the children from Milne's High School may be at risk from being hit by a passing vehicle due to the lack of vision caused by the parking of vehicles on the bad bend over the bridge next to the burger van

I am writing to make art objection to having the above application approved.

This burger van has been operational for some months and all the foreseeable problems that have accompanied this have been confirmed.

- 1 The van is used by workers from the by pass parking their vans at the burger van/garden. The garden/van is at the bend of the road, the parked vehicles cause an obstruction to the view of the road.
- **2** They also stop the flow of the traffic. The congestion builds up stopping the flow of the traffic, resulting in cars not being able to move forward and not being able to reverse back.
- **3** This is added to as the build up of traffic then affects the flow going through the traffic lights at the end of this road. It is an even bigger problem when the school buses are stuck in amongst this and the volume of traffic increases coming from and leaving from the school at the beginning and end of the school day. The by pass will be finished and the workers will go away however the congestion from burger van customers will not.
- 4 This is a designated area for residents it is not for commercial use.
- **5** The neighbours at Burnbank are predominantly elderly and directly across from this house is a disabled person. The burger van will attract youths/the public to this quiet part of Fochabers which may result in neighbours feeling intimidated and being bothered by noise.
- **6** At lunchtime there are around 30-40 pupils from the High School who go to the van and "hang about" while waiting to get served or eating after they have been served. The build up of pupils has grown as word has spread that the burger van is there, amounting to large numbers congregating at a dangerous part of the road as the bend is in front of this garden. Again the traffics view is obstructed with youths, an accident in the making. The garden is right next to the burn which has litter strewn in it and on its newly planted banks.
- **7** The bridge next to the burger van site is often used by tourists and locals admiring the view. The Speyside Way is parallel with this garden as it the Fochabers Community Walks the garden is visible from these paths regardless of the time of the year.
- 8 Fochabers is going to be in a new situation once the bypass is completed. The community in Fochabers have pulled together with the support of Angus Robertson MP. Richard Lochhead MP, George McIntyre Convener of Moray Council and Anita McDonald Councillor. All attempting to ensure that Fochabers will be attractive to tourists and visitors enough to visit and not by pass. The history of Fochabers the uniqueness of the shops the beautiful scenery is all being used to keep Fochabers a popular destination.

At present there are 2 shops in Fochabers vacant, 2 empty shops in a village where someone wants a permit to operate a burger van from their garden. Why give permission for a business to operate in a residential area on the bend of the road when there are two empty commercial premises available.

Moray Council has a responsibility to make sure that this burger van does not have permission to operate in a garden on a dangerous bend. It should be encouraging this business to expand by all means, but in a property that is suitable and fit for purpose.
