On receipt of any representations, these will be forwarded to the applicant who will have 14 days to respond thereon. Thereafter, arrangements will be made for a meeting of the Moray Council Local Review Body (MLRB) to consider the Notice of Review and you will be notified of the date, time and venue. A copy of all documents and notices in respect of the Notice of Review to be submitted to a meeting of the MLRB will be made available for public inspection, prior to the meeting, at the Access Point, Council Office, Elgin and on the Council's Internet website.

In the event of no further representations being received, the Notice of Review and all relevant documents will be referred to a meeting of the MLRB for consideration and you will be notified of the time, date and venue.
