#### **Reasons for refusal**

MLP2008 Policy T2: Provision of Road Access

The proposed development is for a hotel with 22 bedrooms and a 90 sqm restaurant area and a 100 sqm bar area. The hotel/restaurant would be access via the U58E Wester Alves Road, which is a single track road with limited passing places and restricted forward visibility at some locations. There is also evidence of verge over run at locations along this road.

The operation of this hotel and restaurant would be a significant intensification of use at this location and would add traffic to the U58E Wester Alves Road in terms of movements by guests, staff, diners at the restaurant and deliveries. It is unclear from the planning application drawings and material supplied as to the number of and size of additional vehicles which would be associated with the daily operation of the hotel. This information is required to assess this planning application and it is requested that the applicant supplies the information required by filling form TA 1 and the rural development check list (attached to email).

The information will assist in determining the impact of the development on the public road network and the extent of upgrading required along the U58E from the A96 (to the south) to the B9089 (to the north). Note: the applicant has previously stated that traffic would only be accessing the site from the B9089 to the north. Transportation does not agree with this statement and consider that traffic would be accessing the site from the B9089 to the north and the A96 to the south.

Should the applicant take into account the above information requirements and submit the required information to the satisfaction of Transportation, then Transportation will review this recommendation.
