He was advised that unfortunately Heldon Community Council cannot intervene. He was advised that this could be a legal matter and he should inform the police of his concerns.
- 4.3 It was noted that strimming has not be done around the grave stones in Birnie, Spynie and Duffus but the grass has been cut. Cllr. Ross is going to look into the matter.
- 4.4 Potholes noted between Dallas Lodge and Ditchead on the C12E. Secretary to contact roads.
- 4.5 Verges have not yet been cut between Buinach and Dallas.B9010
- 4.6 Over hanging trees noted from A96 to Ardgillan House. C26E
- 4.7 Thanks to go to road department on the white arrows painted at Fogwatt.
- 4.8 Secretary has been asked to enquire why the roadside litter bin at Gateside has been removed. Litter is piling up there. The secretary will contact the departments concerned on these matters.
