A MEETING TOOK PLACE IN BHS BUCKIE ON TUESDAY 15TH APRIL, 2014 AT 7PM.

CHAIRMAN – The meeting was opened by James Smith (Vice Chair) who explained that Trisha Greenwood was not present due to a recent operation and she had requested him to take the chair on her behalf. As there were no Police Officers at the meeting and no Police Report available the Community Warden gave his update.

There have been 3 anti-social behaviour incidents, 2 for persons feeding seagulls and 1 for noisy parties. All incidents have been attended and closed.

Dog Fouling – 1 incident created for persons reporting dog fouling to Moray Council, and 1 complaint to community warden. The community warden has issued 1 FPN. Community warden has carried out dog fouling leaflet drops around reported areas and displayed posters around some of the areas reported.

Details were provided at the meeting regarding dog fouling campaign to run throughout April.

Community Warden now has access to a pedal cycle and will utilise for patrols, he will also to attending Bikeability training in April – this will give the qualification to use at primary schools to assist in cycling safety.

Moray Council along with the Northern Scot are running an Anti-litter Campaign throughout May and community participation is encouraged.

Community Warden has organised for Coastguards to assist with litter clearing at Buckie Burn.

Councillor Cowie asked Community Warden if it was in his remit to organise cycling training for school children. The warden stated this had been cleared by his superiors.

John Cowie stated he had complaints about quad bikes and Pot o' Linn and old Highland Railway Line.

James Smith reported the newly tarred pathway along old line is being used by cars. Councillor Cowie said bollards were going up soon.

The Chairman thanked Andrew Mackie for his update and contribution before leaving the meeting.

3. Sewage Plant - Councillor Cowie informed the meeting that a rep would be willing to address the CC regarding complaints etc. if invited.


