#### 1 Police Report

### Parking at Brodie Pond

It was noted that The Moray Council had given good reasons not to mark the road by Brodie Pond with yellow lines but would erect signage to indicate that pedestrians and children were crossing the road. TMC also suggested that fencing and clear no parking signs be put up by NTS. The Castle were pleased with this result and AS reported that they are to look at erecting a roadside fence to discourage further parking on the verges.
