The Committee agreed to note the informative presentation by Mr Meldrum and following consideration of the report the Committee agreed to:

- (i) note outcomes of the review of Moray Local Fire and Rescue Plan, attached as Appendix 1 of the report;
- (ii) a report, along with a new Local Fire and Rescue Plan for Moray, being presented to a future meeting of the Committee for approval; and
- (iii) the recent HM Inspection report being brought to the Committee in confidence in August.

8. OPERATIONAL UPDATE – SCOTTISH FIRE AND RESCUE SERVICE – VERBAL UPDATE

Prior to the Committee being provided with the update Mr Rout took the opportunity to announce that Elgin Community Fire and Rescue station had gone live as a coresponse station supporting the Scottish Ambulance Service to respond to Out of Hospital Cardiac Arrest where they are nearer to the patient. He took the opportunity

to invite the Elected Members, Partners and the public to any Moray community fire and rescue station to attend a 20 minute presentation on cardiac arrest and how to save a life.

Thereafter the Committee was provided with an informative Operational Update – Scottish Fire and Rescue Service by David Meldrum, Group Manager, Elgin City Fire Station.

The Committee agreed to note the informative update by David Meldrum, Group Manager, Elgin City Fire Station.

9. POLICE PERFORMANCE

Under reference to paragraph 2 of the minute of the special meeting of this Committee dated 26 March 2014 a report by Chief Superintendent C Thomson, Divisional Police Commander, North East Division, Police Scotland on Police Performance. With the permission of the Chair, Chief Superintendent Thomson introduced Chief Inspector D Ross who provided Committee with an overview of the transition since the Aberdeen control room ceased operation and invited Members to visit the control room in Dundee to see the operation for themselves.

Thereafter the Committee agreed to:

- (ii) note that the Local Commander will continue to report to the Committee quarterly on performance measures against service objectives as articulated in the 2017-20 Local Policing Plan, yet to be approved;
- (iii) receive a more detailed report on group 2 incidents to a future meeting of the Committee; and
- (iv) join with Councillor Allan in commending the officers for work undertaken in relation to drugs raids.
